

TERMS AND CONDITIONS OF ROBOCASH PRIZE CAMPAIGN

1. Terms and definitions

- 1.1. **Campaign** – ROBOCASH prize campaign during which Participant of the Campaign can win Prize Money as per these terms and conditions.
- 1.2. **Prize Money** – Monetary prizes expressed in EUR (Euro) that Participants of the Campaign can win if participating in the Campaign as per these terms and conditions, considering the following distribution of prizes:
 - 1.2.1. 1st, 2nd, 3rd place – **EUR 1000** (each)
 - 1.2.2. 4th place - **EUR 700**
 - 1.2.3. 5th place - **EUR 500**
 - 1.2.4. 6th place - **EUR 400**
 - 1.2.5. 7th place - **EUR 300**
 - 1.2.6. 8th place - **EUR 200**
 - 1.2.7. 9th place - **EUR 100**
 - 1.2.8. 10th place - **EUR 50**
- 1.3. **Participant of the Campaign** – User which meets the conditions enlisted in clause 2.1. of these terms and conditions.
- 1.4. **ROBOCASH** – ROBOCASH d.o.o., registration number: 081224371, registered address: Croatia, Petračiceva 4, Zagreb, 10110, e-mail address: support@robo.cash
- 1.5. **Ticket** – unique six-digit number generated randomly that will appear on the “Summary” page in virtual account for the respective Participants of the Campaign in a tab next to the “Euro” on March 11, 2021.
- 1.6. **User** – Natural or legal person registered on the Website of ROBOCASH.
- 1.7. **User’s virtual account** – User’s virtual account created and maintained by ROBOCASH for each User available at the User’s profile on the Website of ROBOCASH reflecting the amount of available funds.
- 1.8. **Website of ROBOCASH** – Website of ROBOCASH, which is located at web address <https://robo.cash>, where natural and legal persons can register as users and use the services available at it.

2. Covenants

- 2.1. In order for the User to participate in the Campaign and draw of the Prize Money through received Tickets (if any) the following conditions have to be met:
 - 2.1.1. In between **February 19, 2021** (GMT +2) to **March 10, 2021** (GMT +2, inclusive) additional funds equal or exceeding **EUR 500** have to be deposited on User’s virtual account and at least part of these newly transferred funds have to be invested, considering that on **March 10, 2021** (“**Review Date**”) ROBOCASH will review the net balance of User’s virtual account during the said time period (**February 19, 2021** (GMT +2) to **March 10, 2021** (GMT +2, inclusive) and every newly transferred **EUR 500** (or higher sum) will generate a Ticket (for example, if on the Review Date ROBOCASH will find that the net balance of User’s virtual account during the said period increased by EUR 1500 with made investments of this newly deposited sum, particular User will be rewarded with three Tickets);
 - 2.1.2. No withdrawal of funds off User’s virtual account can be made in between **March 11, 2021** (GMT +2) to **March 23, 2021** (GMT +2, inclusive), considering that any withdrawal of funds automatically ends Users participation in the Campaign and all issued Tickets are considered null and void.
- 2.2. On **March 25, 2021** through use of third-party website/app ROBOCASH randomly draws winning ticket from all generated Tickets one-by-one from 10th to 1st to establish in which order Prize Money is distributed and which Participants of the Campaign have won the respective Prize Money, considering that this stated draw will be live streamed on Robo.cash channel on YouTube, the recording of which will be available on the same channel after the stream is finished.
- 2.3. Legal relations between the User and ROBOCASH are governed by Website of ROBOCASH user agreement and all of its integral parts posted on the Website of ROBOCASH, including these terms and conditions.
- 2.4. Terms that are capitalized in the present terms and conditions have the same meaning as the terms used in the Website of ROBOCASH User Agreement unless otherwise indicated in the present terms and conditions.
