

TERMS AND CONDITIONS OF ROBOCASH REFER A FRIEND CAMPAIGN

1. Terms and definitions

- 1.1. **Campaign** – ROBOCASH Refer A Friend Campaign, whereby User's and New Users are eligible for Rewards in accordance with these terms and conditions of ROBOCASH Refer a Friend Campaign.
- 1.2. **Campaign Validity Term** – starting with October 20, 2020 until the date unilaterally set by ROBOCASH, considering that ROBOCASH informs its Users on the end term of the Campaign with 10-day prior written notice through ROBOCASH chosen means of communication with its Users, which can also include postage on Website of ROBOCASH.
- 1.3. **Invite Link** – Unique link or code made available for User's at User's virtual account designated strictly for the Campaign, considering that ROBOCASH unilaterally determines the link/code under which the relevant registration was made and whether certain user of ROBOCASH qualified for any payments from ROBOCASH.
- 1.4. **New User** – Natural or legal person registered on the Website of ROBOCASH on basis of User's sent Invite Link.
- 1.5. **Reward** – reward paid by ROBOCASH within 1-day following Reward Calculation Period to User and New User, which is calculated solely by ROBOCASH during Reward Calculation Period and in accordance with terms and conditions of ROBOCASH Refer a Friend Campaign.
- 1.6. **Reward Calculation Period** – unique 30-day time period for each separate New User following the day the particular New User is registered on Website of ROBOCASH, considering that New User registration has to be made during the Campaign Validity Term.
- 1.7. **Reward Calculation Base** – New User's amount invested in current loans on ROBOCASH investment platform available at Website of ROBOCASH on day 30 at 23:59:59 (GMT+3) of the Reward Calculation Period.
- 1.8. **ROBOCASH** – ROBOCASH d.o.o., registration number: 081224371, registered address: Croatia, Petračiceva 4, Zagreb, 10110, e-mail address: support@robo.cash
- 1.9. **User** – Natural or legal person registered and verified on the Website of ROBOCASH that has made at least one deposit on Website of ROBOCASH.
- 1.10. **User's virtual account** – User's virtual account created and maintained by ROBOCASH for each User available at the User's profile on the Website of ROBOCASH reflecting the amount of available funds.
- 1.11. **Website of ROBOCASH** – Website of ROBOCASH, which is located at web address <https://robo.cash>, where natural and legal persons can register as users and use the services available at it.

2. Covenants

- 2.1. All Users and New Users are eligible to participate in the Campaign during the Campaign Validity Term.
- 2.2. Each User holding a User's virtual account will have Invite Link's made available by ROBOCASH at its User's virtual account for the purposes of attracting New Users and receiving Rewards, considering that Users are prohibited:
 - 2.2.1. to post Invite Link on websites that provide erotic, pornographic and indecent content;
 - 2.2.2. to use the Invite Link which ROBOCASH qualifies as unfair commercial practice at its own discretion;
 - 2.2.3. to post Invite Link on websites that involve any kind of gambling and / or betting activities;

- 2.2.4. to post Invite Link on websites that involve download and / or upload of illegal content;
- 2.2.5. to post Invite Link on public channels, such as websites, blogs, Youtube videos, public comments sections, etc.;
- 2.2.6. to use automated systems such as scripts, browser extensions, dialers or bots to distribute Invite Links.
- 2.3. ROBOCASH reserves the right to stop the Campaign at any point in time for any reason, including reserves the right to withhold payment of any Reward if it has any concerns whatsoever regarding the actions of User and/or New User's in respect of the Campaign.
- 2.4. User and New User are eligible to receive Rewards from ROBOCASH in these particular instances:
 - 2.4.1. User receives a one-time **10 EUR** Reward if Reward Calculation Base ranges from **500 EUR – 999.99 EUR**;
 - 2.4.2. User receives a one-time **20 EUR** Reward if Reward Calculation Base ranges from **1000 EUR – 1999.99 EUR**;
 - 2.4.3. User receives a one-time **30 EUR** Reward if Reward Calculation Base ranges from **2000 EUR – 4999.99 EUR**;
 - 2.4.4. User receives a one-time Reward equal to **1.5%** of the New User's made investment in current loans on ROBOCASH investment platform available at Website of ROBOCASH if Reward Calculation Base ranges from **5000 EUR** and greater;
 - 2.4.5. New User receives a one-time Reward equal to **1%** of the amount invested in current loans by New User on day 30 at 23:59:59 (GMT+3) available at Website of ROBOCASH.
- 2.5. ROBOCASH undertake to pay the Reward to User's and New User's by crediting its virtual accounts at ROBOCASH within 1-day following Reward Calculation Period considering the conditions set out in clause 2.4. of these terms and conditions of ROBOCASH Refer a Friend Campaign and only in case the following requirements are met:
 - 2.5.1. New User is registered with ROBOCASH using the Invite Link during the Campaign Validity Term;
 - 2.5.2. New User is not the same person as the User;
 - 2.5.3. New User's virtual account at ROBOCASH is approved by ROBOCASH with all requirements set by ROBOCASH fulfilled during the Campaign Validity Term;
 - 2.5.4. User and New User have not violated any of the conditions set out in these terms and conditions of ROBOCASH Refer a Friend Campaign.
- 2.6. ROBOCASH reserves the right to stop the Campaign at any point in time for any reason, including reserves the right to withhold and/or cancel payment of any Reward in case of any violations of any of the applicable terms and conditions that govern legal relationship between the parties or in case the particular user of ROBOCASH already qualifies and is paid under other similar campaigns such as ROBOCASH Promo Code Campaign and/or ROBOCASH Affiliate Program, for instance, ran by ROBOCASH and/or ROBOCASH cooperation partners such as Target Circle as defined under the Terms and Conditions for ROBOCASH Affiliate Program.
- 2.7. Legal relationship between the User, New User and ROBOCASH are governed by Website of ROBOCASH user agreement and all of its integral parts posted on the Website of ROBOCASH, including these terms and conditions of ROBOCASH Refer a Friend Campaign.
- 2.8. Terms that are capitalized in the present terms and conditions of ROBOCASH Refer a Friend Campaign have the same meaning as the terms used in the Website of ROBOCASH User Agreement unless otherwise indicated in the present terms and conditions of ROBOCASH Refer a Friend Campaign.
